Physician training on the risks of Rx opioids should be mandatory and include

information on immediate-release (IR) as well as extended-release (ER) and longacting (LA) formulations, a **U.S. Food and Drug Administration** (FDA) advisory panel concludes. At a 2-day joint meeting, the FDA's Drug Safety and Risk Management Advisory Committee and its Anesthetic and Analgesic Drug Products Advisory Committee unanimously voted to modify the ER/LA opioid analgesic Risk Evaluation and Mitigation Strategies (REMS).

Nearly one-third of opioid prescriptions paid for by employers are abused, according to a new report by Castlight Health Inc. The report aims to "provide employers with a more accurate picture of opiate painkiller abuse in the workplace, so they can better understand the extent and depth of the crisis," the San Francisco-based health care information company said in a statement.

Doctor David Kessler, who ran the FDA from 1990 to 1997, doesn't hold back when talking about the explosion in opioid use in the last two decades. "This has been one of the great mistakes of modern medicine," said Kessler, who went on to say opioid addiction in the U.S. amounts to an epidemic. "FDA has responsibility, the pharmaceutical companies have responsibility, physicians have responsibility. We didn't see these drugs for what they truly are."
